Sensex and Nifty lost 3 percent each in the past week amid fresh crisis in the financial sector which dampened the positive sentiment brought after the cut in the corporate tax rate. In the last week, the Sensex plunged 1,149.26 points (down 2.96 percent) to end at 37,673.31, while Nifty shed 337.6 points (down 2.93 percent) at 11,174. The S&P BSE Midcap index declined by 3.87 percent while the Smallcap Index was down by 3.92 percent in the past week.

The Reserve Bank of India's repo rate cut also did not bring any cheer for the Indian markets, which were under pressure due to fresh concerns over global trade.

The RBI's monetary policy committee on October 4 slashed rates by 25 bps and kept the stance accommodative to revive growth in Asia's third-largest economy.
