Nifty and Bank Nifty touched their respective record highs in the past week supported by rally seen in the global markets. In the past week, the Sensex 1.63% while the Nifty added 1.53%. The BSE small-cap index rose 0.44% in the past week. US markets touched new highs as sentiment had been bolstered after US Treasury Secretary Steven Mnuchin said the United States and China would sign their Phase 1 trade pact in early January. In the current trading week among the major sectors FMCG-FOOD has outperformed with 3.32%, followed by Metals and Mining and Realty with 3.02% and 2.12% respectively. As far as minor sector is concerned Packaging lead with 3.87% change, followed by Paper and Sugar with 3.56% and 2.90% change respectively. Flls remained net buyers the past week as they bought equities worth Rs 4,891.7 cr, while Dlls sold equities worth of Rs 3,751.47 cr.
