Indian indices ended marginally lower in the truncated week ended December 27 on the back strong recovery witnessed in Friday's trading session. The market remained highly volatile and ended lower for the first three trading session of the week amid F&O expiry, capital infusion in state-run banks by the government and positive global markets on the back of progress on the first phase of trade deal between the US and China. In the past week, the Sensex shed

-0.25%, while the Nifty shed -0.21 %.The BSE small cap index rose 1.17 percent, BSE midcap index rose 0.63% in the past week.

On the global front, during the week the NASDAQ crossed the 9,000-point mark for the first time with all three major Wall Street indices posted record closing highs, boosted by optimism over US-China trade relations. FIIs remained net buyers the past week as they bought equities worth Rs 926.14 cr, while DIIs sold equities worth of Rs 2046.35 cr.
