Indian indices ended marginally lower for the second consecutive week ended January 3 on the back of global developments. The escalating geopolitical tension hit investor sentiment after a senior Iranian military official was killed by a US airstrike. In the past week, the Sensex shed -0.26% while the Nifty shed -0.15%. The BSE small-cap index rose 3.26 %, BSE mid-cap index added 1.24 %.On the global front, during the past week, US major indices touched record highs after fresh economic stimulus from China added to optimism fueled by easing trade tensions between in the two countries. Brent crude prices surged more than 4% in the session on Jan. 3 and gold prices also climbed to a four-month high as tensions mounted in the Middle East. FIIs remained net buyers in the past week as they bought equities worth Rs 497.32 cr, while DIIs also bought equities worth of Rs 29.61 cr.
