Benchmark indices might have hit fresh record highs, but the real action was seen in the small and mid-cap space which outperformed both the Sensex and Nifty by a wide margin for the week ended January 17. The S&P BSE Sensex rose 0.83 percent while the Nifty50 ended with gains of 0.78 percent for the week ended January 17.

Broader markets outperformed as the S&P BSE Mid-cap index was up 3.6 percent, and the S&P BSE Small-cap index closed with gains of 3.97 percent for the week ended January 17. The Nifty Midcap index hit a fresh seven-month high on January 17. As many as 123 stocks in the S&P BSE smallcap index rose 10-60 percent in the past five trading sessions. These include Liberty Shoes, MMTC, VIP Industries, Ramco System, Birla Corp, Simplex Infra and Vipul.
