The Indian market ended with marginal loss in the volatile week Where nifty closed at 8660(-0.97%) and sensex at 29816 lower by 0.33%. The BSE Small-cap, Mid-cap and Large-cap indices were down 6 percent, 5.4 percent and 1.28 percent, respectively. FIIs sold equities worth Rs7,165 crore while domestic institutional investor bought equities worth of Rs 4308 crore. This week, there is stability in Global Markets after Senate passed a \$2-trillion Corona virus Economic stimulus package in the US.

RBI Governor announced a massive 75 basis points cut in repo rates as a measure to counter the economic slowdown caused by (COVID-19) pandemic. The Indian Rupee touched a fresh record low of 76.32 per dollar. Volatility can be seen further as investors focused back on the Corona virus outbreak.
