Equity indices extended gains for the fourth straight session with the benchmark BSE Sensex jumping over 950 points The 30-share BSE index closed 997 points or 3.05 per cent higher at 33,717.62while the broader NSE Nifty surged 307 points or 3.21 per cent to close at 9859.90.Markets participants were seen accumulating stocks in anticipation of another stimulus package by the government. The main issue is the duration of this pandemic, its impact on economic growth and how macros of different economies are going to get hurt along the way.

Investor sentiment improved on Hope's that gradual lifting of global lock-downs would help start economic recovery, they added. "The Current stock market direction is a result largely of coordinated moves that we are seeing across the world due to easing restriction". Broader market sentiment, however, remained weak as concerns pandemic weighed on global investor mood.
