Benchmark Sensex and Nifty erased early losses and closed flat with negative bias on this week, inline with overseas trend, as investors anticipated positive measures in the 3rd tranche of announcements for the economic relief package. Sensex closed 25 points lower to 31,097, while Nifty ended 5 points lower at 9,136 Indian indices ended marginally lower after erasing most of the intraday losses on Friday and Nifty managed to close a little above the 9100-level. This is the second straight week that the Indian equity indices ended in the red.

Indian shares ended Friday little changed after details on the government's economic package failed to impress investors already worried about rising coronavirus cases and poor earnings reports. "Analysts have pointed out that the measures amount to limited fiscal spending, and that although they provide businesses and workers with liquidity, the steps will do little to stimulate consumption demand and provide a boost to the economy in the short term".
