The Indian benchmark Index Nifty showed strong rally on last two trading days from its low of 10783 to close at 11109 and rose 1.02% in the last week. The Index was supported by sectors such as chemical, cement and pharma. The S&P BSE Midcap index was up 0.91 percent, Smallcap Index added 1.63 percent. Monetary Policy Committee (MPC) of the Reserve Bank of India (RBI) slashed key rates for the fourth time in a row on August 7.The committee has reduced repo rates by another 35 basis points to 5.4 percent in the August Policy review while maintaining an accommodative stance. It now stands at the lowest level since April 2010.

India faced a major change in its constitution under Article 370 which may see major changes in Jammu & Kashmir. Scheduled meeting of the overseas investors with the FM on Friday, to ease their tax concerns further boosted the sentiment.
