Indian equity markets rebounded sharply from the lows of the day, to end with gains, near the highest point of the day. However, the surge was not enough to prevent losses on a weekly basis. The S&P BSE Sensex ended 0.72% higher at 33,780.89. The index recovered 1,432 points from the day's low of 32,348. The NSE Nifty 50 index too ended with gains of 0.72% but failed to cross the 10,000 mark. The index ended at 9,972.90 - with a recovery of 430 points from the day's low of 9,544.

The India Volatility Index ended above the mark of 30, gaining 3.9% to end at 30.82. Market breadth reversed in favour of the advances by the close of trade. 947 stocks on the NSE ended with gains while 852 posted losses. For the week, the Sensex ended with losses of 1.48% while the Nifty reported losses of 1.67%. Both the benchmarks snapped a two-week gaining streak.
