Equity markets ended on a flat note on this week amid lack of fresh triggers and mixed global cues. However, both the Sensex and Nifty posted weekly gains of more than 1%. The Sensex on Friday was up by 14.23 points, or 0.04%, to close at 38,854.55 whereas the Nifty was up by 15.2 points, or 0.13%, to close at 11,464.45. For the week, gains for the markets were primarily contributed by Reliance Industries, whose shares were up by 12%. On a weekly basis, the Sensex advanced 497.37 points, or 1.29%, while the Nifty rose 130.60 points, or 1.15%. On Friday, the NSE futures and options segment witnessed a turnover of Rs 11.21 lakh crore, against the six-month average of Rs 15.43 lakh crore. The cash market segment saw a turnover of Rs 51,408.71 crore, against the six-month average of Rs 53,128 crore. Foreign portfolio investors (FPIs) on Thursday bought stocks worth \$110.3 million while domestic institutional investors sold stocks worth \$41.7 million.
